FIRE DEPARTMENT STAFFING

CHIEF TOM HEWITT

November 1, 2011

In the past few years the average number of Volunteer Firefighters responding to calls has decreased. This decrease has been most prevalent during day time emergencies. Although this is not limited to our fire department, we need to be concerned for the people and property of Little Egg Harbor Fire District #2. I have been researching what other fire departments do to make sure that a fire truck responds to day time calls. Of course there are some that have full time staff, I don't feel that this is necessary at this time. Lakewood Fire Dept. and Linwood Fire Dept. utilize paid drivers, that is very effective. Some departments have instituted an incentive program, such as "pay per call". With this there is a set dollar amount for each call a member makes. This too can be very effective, but does not guarantee that a fire apparatus will respond.

The following are my recommendations;

Hire 1 full time driver/officer to be at the station Monday – Friday. Respond to all emergency calls in Little Egg Harbor Fire District #2. He would be responsible for proper care and oversee repairs for equipment and apparatus. Must be capable of operating as Incident Command on emergency scenes. Must have IMS 400 (Incident Management Level II) and NIMS 700 & 800 (National Incident Management System). Possibly respond to Emergency Medical calls in the Fire District.

AND

Institute a Volunteer Firefighter Incentive Program (Pay Per Call). This program will provide a monetary incentive to our firefighters per emergency call they respond on. They are still considered volunteers and not paid staff. The firefighters still have their normal jobs and are volunteering on their spare time. The firefighters who want to be included in the program must sign an agreement. And maintain a certain percentage throughout the year in order to remain in the program.

Hire 6 Part-Time Firefighters to staff an Engine Monday - Friday. Two of the firefighters would need to be ranked as leads for their shift. And the incentive program.
