- The fire pump on 7206 is hazardous to boat due to heat fumes and mechanical issues. A Hale pump will cost \$2,800 to replace it.
- Portable radio was loaned to the Police Dept. because their fire radio went down. He will follow up on the return of it.
- Quotes for new chiefs vehicles were received; need quotes for lettering.
- TIC camera parts are on order.

- 1. 7201, the deck gun modification is complete and the workmanship exceeded our expectations.
- 2. 7207 air tanks (qty4) need to be hydro-tested; this was last done in 2008. Quote attached from Air & Gas.
- 3. Nomex hoods needed. Request to order 10. Quote attached.
- 4. Request being submitted to order 3 to 5 sets of turnout gear. Recommendation and quotes attached.
- 5. Researching options to replace the fire pump onboard 7206. The current pump is mechanically failing and proving to be a hazard to the crew. Suggestions for a replacement to follow.
- 6. 1 portable radio is on loan to Police Communications while the PD base radio is being repaired.
- 7. Final quotes have been received for the new 7200 and 7210 command boxes. We are still gathering information and prices to wrap and letter the trucks.
- 8. The parts have been ordered for the old TIC in 7205. Shawn Hope will handle remounting the cameras in 7205 and 7200.
- 9. The Holmatro is back in service and mounted on 7201
- 10. Prop and Indder testing are scheduled for this coming August.
