He recommends that ERS do the pump service on both trucks @ \$250 each and repair the two valves @ \$1,500 for 7205 and possibly on 7201. He reported that Nat Alexander is to provide a quote to repair 5" driver side discharge valve leak, and ERS is to provide quote for repair of leak in the pump to ladder discharge valve at 200 psi on 7205.

For the month of August we ran a total of 6 calls totaling 95 calls for the year.

- 1. Currently the apparatus is operating properly with the exception of a few small things. On 7201 at times the 5" driver side discharge valve leaks and this causes concern due to pressure building behind the cap. At this time I have been able to resolve the issue but at some point I recommend the valve be serviced (this is not an OEM part from Pierce it was taken from 7211). All pump and hose testing was successful on 7201
- 2. On 7205 pump testing revealed a leak in the pump to ladder discharge valve at 200 psi. This problem should be addressed sooner than later before it worsens. Also three 100' lengths of 5" hose failed testing and are removed from service. 7205 still has 700' of 5" so I see no urgent need to replace the hose on the truck. Although I would recommend purchasing two or three lengths to keep in the station as a replacement in the event of hose damage or a failure on either apparatus.
- 3. Pump and hose testing reports were forwarded to the commission for review and record keeping.
- 4. Still waiting for the parts for the old 7205 TIC. I contacted the Continental Fire and Safety to discover they had a mix-up in the order pulling process. I was assured the problem was resolved and we should have the parts in one or two weeks.
- 5. We have a good problem developing with membership. We have taken on several new members recently; unfortunately we have a pager shortage. While the fire Company purchased the several pagers we are still short. I would like to request three more pagers at the approximate cost of \$375.00 each totaling \$1,125.00.
- 6. After researching several options for a fire pump to be placed on 7206, we've determined a floating pump makes the most operational and financial sense. This pump can be easily moved between different vehicles for different applications. Also it can be taken to the station for routine maintenance and flushing after being used. See attached quote for recommendation.
