- 3. We have discovered the SCBAs are out of date on the flow testing. Question to the Commission, should we proceed with quotes to have this testing done.
- 4. We did a test run of handling our own rehab at the live burn. This proved very successful and our intensions are to move forward in establishing this as a function of the medically trained associate members.
- 5. The radios have been installed in 7206. We will be launching the boat shortly. The new chargers are hooked up to the jet skis and they are in service.
- 6. Annual FIT Test is taking place this evening 17:00 to 19:30. This testing is also required by OSHA
- 7. We received the closeout letter from the employment section of OSHA. The last few items for the DOH are in the process of being completed. We have until August 17, 2018 to complete the open citations.
- 8. One of the OSHA DOH items we have to comply with is not all membership files have proof of receiving a physicals. We will need to have this corrected for approximately 16 members.
- 9. We have several members that have become eligible for class A uniforms.
