For month of June the Fire Company responded to 15 calls for a total of 75 calls to date.

1. The new voltage detectors and cable cutters have been received and placed in service on 7200, 7210 7201 and 7205.
2. The port motor water flow issue on 7206 seems to be acting up again. The synchronization issue still exists. 7246 and 7256 are back in service. We have a price of one hundred and sixty five dollars to replace the damaged mirror on 7256.
3. We have air packs and some pressurized water extinguishers in need of repair.
4. The new battery operated saws are in. We will do some hands on training then place them in service.
5. All apparatus is functioning properly with no issues to report. Annual hose pump and ladder testing is scheduled for August.
6. I would like to request the purchase of four (6) Water Pressurized fire extinguishers (aka water cans) to be placed in service. The extinguishers we currently have are older models showing their age and beginning to fail. My request is not to exceed five hundred dollars.
7. All of the OSHA violations have been resolved and we received verbal confirmation all issues were abated. We are awaiting written confirmation.
