Minutes of the previous meeting – A motion was offered by Mr. Gulbert, seconded by Mr. Caronia that the reading of the minutes of the previous meeting be waived providing that the minutes shall be made available for inspection by any member of the public during the meeting.

Secretary's Report – Nothing to report.

<u>Fire Police</u> – Mr. Caronia reported that he has contacted the insurance company regarding the coverage for Fire Police. They would have to attend classes for training and receive their certifications. Then, they can be added on to the insurance policy. The Board will need to know how may people the fire department is going to have as Fire Police to determine if there are enough funds in the budget to do so.

<u>Driving of Fire Apparatus</u> – Mr. Caronia also reported that the insurance company advised that drivers of fire apparatus must be 18 years of age, and would be covered under insurance. But the Commissioners bylaws indicate that the driver must be 21 years of age.




