1. Currently no members are in quarantine from Covid-19. We will continue decontamination practices and PPE usage.
2. The new ladder safety belts and water can straps are on order and should be in soon (hopefully). 5" gated valves have been ordered.
3. The shore-power plug has been installed on 7237. 7237 is in need of new batteries. 7200 reverse light burned out and new bulbs are on order expected cost \$40 for 2. 7210 is still out for repair w/unknown completion date. The rear scene lights are replaced on 7205. 7201 will be leaving July 13 for the evaluation and quote for the repairs needed. 7201 step light has been repaired.
4. Other than the noted items above all the apparatus is functioning properly.
