Our intent is to provide the following:

 Provide and install a 4 channel marine battery charger and connect one leg to each of the 4 batteries on the truck. Install the charger in best possible location and run all of the wiring from the charger to the batteries. Secure the wiring out of the way and make all weather proof connections. Test operation of the charger and make any adjustments as needed.

Total \$ 1,223.75

2. After the batteries are fully charged we will load test them and if any of them test poorly we will replace all 4 with new GR31 batteries.

Total \$ 770.00


