WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on November 11, 2025 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2026 and ending December 31, 2026 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

The 2026 Budget has decreased by -\$335,343.87 or -37.5% from 2025. The total 2026 budget is \$559,156.13 and the 2025 budget was \$894,500. This is primarily due to less Capital Appropriations of \$350,000.

Restricted Fund Balance decreased \$362,096.62 or -100%, Interest on Investments & Deposits increased \$10,000 from favorable interest rates, Travel Expense decreased -\$3,000 or -27.3% from less need, Losap increased \$5,000 or 12.5% due to increased volunteers, Insurane increased \$13,000 or 27.7% due to increased premiums, Other material and supplies increased \$1,000 or 50% from increased prices in supplies, Training and Education decreased -\$4,000 or -33.3% do to less need.
